Competition	Friday and Saturday Powerlifting (depending on the number of starters shortened to Saturday), Sunday Benchpress and Deadlift, starting at 10.00 am

Weigh-in	Thursday, Friday and Saturday from 6pm to 8pm Friday, Saturday, and Sunday from 8am to 9:30am
Awards:	medals or cups for all places. Relative prizes depending on entries. Lifters must participate in the awards ceremony to receive any awards.

By registering, the participant or his legal guardian agrees to the following conditions:

- The participant accepts the conditions specified in the invitation to tender.
- **The award ceremony is part of the competition event. We reserve the right to exclude starters, who do not take part in the award ceremony without compelling reason, from further competitions of the GPU and to remove them from the results lists.**
- He / she participates completely at own risk in the competition.
- There is no liability on the part of the competition management, the World Powerlifting Union, the German Powerlifting Union eV and its members, the city of Düsseldorf, the host, the operators of the competition venue, their officers, employees or representatives for losses, damages or injuries suffered, however, caused, in any way, by my participation in the event, even if the liability arises from negligence or carelessness on the part of the named persons or companies mentioned.
- He / she understands that I am not insured for injuries and property damage (neither health nor liability insurance).
- There is no monstrous Grand from which he / she can not participate in the competition.
- For each start, he / she transfers the participation fee to the account of the German Powerlifting Union e.V.
- The entry fee will not be refunded.
- The message can only be considered upon receipt of the entry fee.
- I agree to provide proof of age for my age by presenting the identity card or passport.
- Consent for the use of personal pictures: By submitting the message and transferring the entry fee, I also give my consent for a possible publication of photos or film contributions that are created in the course of the event and my person or children, for whom I care for the people have, picture. The images are not alienated and used exclusively for press releases (publication in media from the area pressure / online / TV / radio as well as on the club homepage) and for advertising purposes of the association. My consent also extends to the case where the aforementioned media are used for on-site reporting.
